



**I have volunteered** to participate in WRTC2014 (the “Event”), and I agree to this release and waiver (the “Release”).

This Release applies to the Event, including free time during the Event. It applies to all travel to, during, and from the Event, as well as any other pursuit incidental to the Event, including training and testing in preparation for the Event during 2012 and 2013. I am aware of the potential dangers associated with this type of Event, and I know that those dangers include additional costs, as well as the chance of injury or death.

As consideration for being permitted, by WRTC2014, Inc. to participate in the Event, on behalf of myself, my heirs, distributees, and assigns (“Releasors”), **I release and waive any cause (or causes) of action** that may arise from the Event against any officer, agent, volunteer, participant, or employee, of WRTC2014, Inc. (the “Releasees”), insofar as New Hampshire law allows. Nonetheless, **common carriers, as well as commercial restaurants and hotels, are not among the Releasees.** I am agreeing that I cannot, and will not, bring any cause of action, including a lawsuit, against a Releasee. This Waiver and Release applies to claims that arise from negligence or other non-intentional conduct of any Releasee in conjunction with the Event. **While I agree that I unconditionally release and waive all claims of any kind against WRTC2014, Inc., I do not release or waive claims against a person who is otherwise a Releasee, if that Releasee acted with intent to cause physical harm to me.**

Except as described above with respect to common carriers, commercial restaurants and hotels, as well as intentional acts as described above, I also agree to indemnify and hold harmless the Releasees from any loss or liability, including attorney fees, which Releasees may incur should there be a legal action if I am injured or die, suffer pecuniary loss, or suffer damage to my property as a result of my participation in the Event. I understand that this Release is intended to be thorough and complete. I completely understand that **I will be personally responsible for my own safety during the Event.**

I’ve read this Release, and I’m signing it voluntarily. Any oral statement to the contrary, by anyone, won’t change this Release, as it may only be modified in writing. Insofar as the law allows, I also agree that my spouse, companion(s), children, and pets are also Releasors. If they are with me, and New Hampshire law allows me to act on their behalf, this Release applies.

**Photographs and Recordings.** I know that there will be photographs and video recordings made during the Event, and I grant the right to use them in perpetuity.

**The laws of New Hampshire shall apply exclusively to this Event and to any claims made as a consequence of the participation of a Releasor.** Should any controversy ever arise with respect to this Release, or any other aspect of the Event, **jurisdiction and venue shall be in Rockingham County, New Hampshire, USA.**
